1	The total number of sections of Bal Vatika shall be restricted to 09 (03 sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 38 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section.
